

# Twenty Fourth Annual Diamond Valley Lake Invitational

Hosted by: Dartmouth Knights

**When:** Thursday, November 13<sup>th</sup>, 2025

**Where:** Diamond Valley Lake Community Park (1801 Angler Ave., Hemet CA 92543)

**Time:** 9:30 am – 1:00 pm (self guided course tour, must be off course by 9:15 am)

**Who:** Boys and Girls in grades 6<sup>th</sup> through 8<sup>th</sup> (six separate races)

Race Order: 6<sup>th</sup> grade girls – 9:30 am      6<sup>th</sup> grade boys – 9:55 am  
7<sup>th</sup> grade girls – 10:20 am      7<sup>th</sup> grade boys – 10:45 am  
8<sup>th</sup> grade girls – 11:10 pm      8<sup>th</sup> grade boys – 11:35 pm  
Awards presentation: 12:15 pm

**Races will be run ahead of schedule, if time allows.** Meet is held rain or shine. Meet officials can cancel/postpone the meet for unseen circumstances.

**Course:** 2.0 miles primarily on a dirt road. A few rolling hills and 1 large hill.  
Start line is on pavement and finish line is on grass.

**Fee:** \$50.00 per race or \$20.00 each athlete. Maximum entry of 72 student athletes per school.  
Additional charge of \$3.00 per athlete over 72 entries.

**Entry fee is based on number of registered athletes (all athletes must be preregistered), not the number of athletes that show up the day of the meet.**
